PRIVACY POLICY

Introduction

Made To Move Studio Pte. Ltd. ("MTM", "we" or "us") takes the privacy of your information seriously. This Privacy Policy applies to the Madetomovestudio.sg website (the "Website") and governs data collection, processing and usage in compliance with the Personal Data Protection Act 2012 (No. 26 of 2012) of Singapore ("PDPA"). By using the Website, you consent to the data practices described in this statement. Capitalized terms that are not defined in this Privacy Policy have the meaning given to them in our Terms of Service.

Information Collected from All Visitors to our Website

We will obtain personal data about you when you visit us. When you visit us, we may monitor the use of this Website through the use of cookies and similar tracking devices. For example, we may monitor the number of times you visit our Website or which pages you go to. This information helps us to build a profile of our users. Some of this data will be aggregated or statistical, which means that we will not be able to identify you individually. This Privacy Policy applies to all visitors to our Website.

Additional Personal Information that May be Collected

MTM may collect and process:

Personally identifiable information, such as:

Your e-mail address and name, mobile when you contact us;

Details contained in the relevant document that you key in when you use our Services. These details may include your name, handphone number, email, photos for social media, the purpose of your query, and details about your will; ("Personal Information")

Information about your computer hardware and software when you use our Website. The information can include: your IP address, browser type, domain names, access times and referring website addresses. This information is used by MTM for the operation of the Services, to maintain quality of the Services, and to provide general statistics regarding use of the madetomovestudio.sg Website.

Use of Personal Information

MTM uses the collected information:

To operate the Website and deliver the Services;

To process, and where necessary, respond to your application, enguiry or request;

To gather customer feedback;

To share via social media and means to promote MTM;

To inform or update you of other products or services available from MTM and its affiliates, where you have consented to be contacted for such purposes;

To monitor, improve and administer the Website and Services, and to provide general statistics regarding user of the Website;

To update you on changes to the Website and Services.

Non-disclosure

MTM does not sell, rent, lease, or release your Personal Information to third parties. MTM may, from time to time, contact you on behalf of external business partners about a particular offering that may be of interest to you. In those cases, your unique Personal Information is

not transferred to the third party without your explicit consent. In addition, MTM may share data with trusted partners to help us perform statistical analysis, send you email or provide customer support. All such third parties are prohibited from using your personal information except to provide these services to MTM, and they are required to maintain the confidentiality of your Personal Information.

Disclosure of Personal Information

MTM will disclose or share your Personal Information, without notice, only if required to do so by law or in the good faith belief that any such action is necessary to: (a) comply with any legal requirements or comply with legal process served on MTM or the Website; (b) protect and defend the rights or property of MTM; and (c) act under exigent circumstances to protect the personal safety of users of madetomovestudio.sg, or the general public. We may disclose your personal information to third parties: (a) in the event that we sell or buy any business or assets, in which case we may disclose your personal data to the prospective seller or buyer of such business or assets; and (b) if madetomovestudio.sg or substantially all of its assets are acquired by a third party, in which case personal data held by it about its customers will be one of the transferred assets.

Use Of Cookies

The Website uses "cookies" to help you personalize your online experience. A cookie is a text file that is placed on your hard drive by a web page server. Cookies cannot be used to run programs or deliver viruses to your computer. Cookies are uniquely assigned to you, and can only be read by a web server in the domain that issued the cookie to you. Cookies on the Website may be used to ensure a smooth user experience, perform analytics, and for showing relevant advertisements. Please note that third parties (such as analytics software) may also use cookies, over which we have no control. These cookies are likely to be analytical/performance cookies or targeting cookies. The Website uses Google Analytics. Most Web browsers automatically accept cookies, but you can usually modify your browser setting to decline cookies if you prefer. Once we have received your information, we will use strict procedures and security features to try to prevent unauthorised access.
